The Museum Board, ARTS Council, and Miss Syracuse Pageant would like to address the council regarding budget requests for the FY2011-2012 fiscal year.

In prior years, the City has annually contributed \$4,000 to the ARTS Council and \$1,500 to the Miss Syracuse Pageant. The City has not contributed anything to the Museum; instead the City pays all utilities, internet, and alarm monitoring. This costs approximately \$7,500 per year. The City also provides all grounds maintenance at the museum but I was unable to figure an annual cost since the museum is included with regular grounds maintenance of the city buildings.
